

## DECLARATION OF JOINT FAMILY

  - a) That we are the present adult co-parceners of the said joint family;

We hereby authorize the karta/Manger Sh. \_\_\_\_\_ on behalf of the HUF to deal on cash/Capital market segment (CM) and/or Derivatives/Futures and options segment (F&O) and/or currency derivatives segment to sell, purchase, transfer endorse, negotiate documents and/or otherwise deal through on behalf of the HUF. He is also authorized to sign, execute and submit such applications, requisite documents and deeds as may be deemed necessary or expedient to open account and give effect to this purpose. We are, however, jointly and severally responsible for all liabilities of the said HUF firm to the member and agree and confirm that any claim due to the member from the said HUF firm shall be recoverable from the assets of any one or all of us and also from the estate of the said joint family including the interest thereon of every co-parceners of the said family, including the share of the minor co-parceners, if any.
3. We undertake to advise the Member in writing of any change that may occur in the Karta / Manager or in the constitution of the said joint family or to the said HUF firm and until receipt of such notice by the Member, the Member will be entitled to regard each of us as a member of the said joint family and as a partner of the said HUF firm and all acts, dealings and transactions purporting to have been done on behalf of the said joint family or of the said HUF firm, before the Member shall have received notice in the manner aforesaid, shall be, binding on the said joint family and the said HUF firm and on our respective estates. We shall, however, continue to be liable jointly and severally to the Member for all dues and obligations of the said HUF firm in the Member's book on the date of the receipt of such notice by the Member and until all such dues and obligations shall have been liquidated and discharged.
4. We recognize that a beneficiary account can be opened with Depository Participant only in the name of Karta as per regulations. To facilitate the operation of the above trading account with you and for the purpose of completing the share transfer obligations pursuant to the trading operations, we authorize you to recognize the beneficiary account no. \_\_\_\_\_ with Depository \_\_\_\_\_ DP ID \_\_\_\_\_ opened in name of Sh. \_\_\_\_\_ who is the Karta/Manager of this HUF.

5. We agree that obligations for share purchase and/or sale by HUF will be handled and completed through transfer to/form the above mentioned account. We recognize and accept transfers made by you to the beneficiary account as completion of obligations by you in respect of trades executed in the above trading account of the HUF.
6. The details of the present co-parceners including the present minor co-parceners and of the said joint family are given below. We undertake to inform you in writing as and when the minor co-parceners attains the age of majority.
